The Invocation was delivered by Pastor Richard E. Simpson and the delegates and guests joined him in reciting the Lord's Prayer followed by the singing of *Beautiful Saviour*. Pastor Simpson then read from the scripture.

Brother Ken Johnson and Brother Stephen Helmold led the tribute to our deceased members. As each Zone was mentioned the bell was rung to remember those from that Zone who have entered Lodge Eternal in the past two years. The Tribute was followed by silent prayer and the singing of *Amazing Grace*.

The Offertory and Doxology were performed by Pastor Simpson.

How Great Thou Art was sung by soloist Lisa Daehlen with Richard Feingold accompanying on the piano.

The delegates and guests sang A Mighty Fortress is Our God.

Pastor Ida Iverson of Gateway to Florida Lodge gave the memorial address:

Luke 6: 46-49

"Why do you call me 'Lord, Lord,' and do not do what I tell you? I will show you what someone is like who comes to me, hears my words, and acts on them. That one is like a man building a house, who dug deeply and laid the foundation on rock; when a flood arose, the river burst against the house but could not shake it, because it had been well built. But the one who hears, and does not act is like a man who built a house on the ground without a foundation. When the river burst against it, immediately it fell, and great was the ruin of that house."

Let us pray: God of grace and glory, we remember before you today our brothers and sister. We thank you for giving them to us to know and to love as companions in our pilgrimage on earth. In your boundless compassion, console us to mourn. Give us your aide, so we may see in death the gate to eternal life, that we may continue our course on earth in confidence until, by your call, we are reunited with those who have gone before us; through your Son, Jesus Christ the Lord. Amen.

As I began to think about the service today, I am reminded that each of the people we are remembering today had a story to tell. A story that told of where they were from, what they had done, who their family was, and the fact is that their story along with each of you here today, and the great cloud of witnesses who had come before you and me, have been a part of this organization called Sons of Norway. Sons of Norway is all about story. As I asked for the scripture from Luke to be read, that too is about a story that Jesus told not only to his disciples but to a great crowd who had gathered around him for healing. This story is about what it is we do when we hear God's word and we live into that word. How God's word becomes part of our story, of our lives.

I am not of Norwegian heritage, but Swedish heritage and I think about all those others who came out of the Scandinavian regions, where the State Church was Lutheran. As they immigrated to the United States and moved in to cities, small towns and the rural areas to start their lives over. In many of these communities, one of the first things they did was to establish a

church, a Lutheran Church, in the new community where they began their new lives, their new stories. The stories of your ancestors and mine.

One of the things that we also know is that family was at the center of their lives and taking care and nurturing those families in the right now and when the time came that they were no longer present because they had entered the church triumphant was part of the firm foundation that they stood upon.

That was the beginning of the story of Sons of Norway, being able to take care of family in what might be thought of as the worst of circumstances, when they would no longer be there to take care of their loved ones. That was the foundation of what has become a much larger story. Did those first immigrants ever dream that what they put aside to care for their immediate family would continue to take care down through so many generations and beyond even the generations that will follow you and me? Did they ever dream that not only would the generations who would follow them would be taken care of, but that the traditions that they brought from their homelands would be preserved for those to follow as well.

That in many respects is why we gather here, because of the foundations that those who came before us held. Those who heard the stories of Jesus and believed. They believed that God had named and claimed them in their baptism. They knew the stories and they passed them on to their children to build their foundations upon. It is that same foundation that brings us here today. It is the love, friendships and loyalty that they passed on that lives within you and me yet today...or we would not be here. I believe that it is also a foundation of faith in Jesus Christ, that bring us to this church to remember those who have gone before us.

There is another story that this reminded me of if, it also is from the book of Luke, it takes place eight day after Jesus is born. Joseph and Mary followed the custom of the time and went to the temple with Jesus to have him circumcised and be given his name...Jesus as the angels had foretold. There was a man there by the name of Simeon, and it had been revealed to him that he would not see death until he had seen the Lord's Messiah. As Joseph and Mary entered the temple Simeon, took Jesus into his arms and sang:

Now, Lord you let you servant go in peace; your word has been fulfilled. My own eyes have seen the salvation which you have prepared in the sight, of every people; a light to reveal you to the nations and the glory of your people Israel.

The glory of not only of the people of Israel, but of all nations around the world. A little over two months ago, young and old gathered to hear the story of Jesus Christ risen. It is the story that sadly so many do not come back to hear the rest of the story. How it is our belief in the story of Jesus we find our true firm foundation of, life, hope, peace, renewal and solid ground to stand upon. It is in Jesus Christ that we can, weather the storms that rage around us figuratively and literally. It allows you and me to be able to step out in faith just as our ancestors did to try something new. That gives us words to speak our own story that the generations who will follow

us, will be told and give them courage to step out knowing that they are not stepping on ground that will shift, but solid ground rooted in Jesus Christ, our true Lord and Savior. Go and tell your story of the solid ground that comes from faith in Jesus Christ, the faith of our fathers and mothers, Norwegians, Swedes, Danes, Finnish. Amen.

The delegates and guests sang the final hymn, America the Beautiful.

The delegates and guest left the Church as Margaret Gythfeldt played the Postlude. The delegates and guests boarded the buses which took them back to the Radisson hotel.

District Lodge No. 3 Officers 2016-2018. Place a double Asterix after the name PR Director James Dunagan. At the bottom of the page add a footnote that he is not a voting member of the District Lodge Board. The reason for this is that section 3.11.1 of the Sons of Norway Policy and Procedures states that only voting members of the District Lodge who are benefit members shall be eligible to hold elected District Lodge Offices. Jim was not a Delegate or Board member at the 2016 Convention so he was not a voting member of the District Lodge. There being no other suitable candidate in 2016 for the position, the Board appointed Jim to the Public Relations Director position, but with the understanding that he was not a voting member of the Board of Directors. Because Jim is not a voting member of the Board of Directors, Jim is also not a voting member of this District 3 Lodge. This is because section 3.1.1 of the Sons of Norway Policy and Procedures states that the District Lodge will consist of its elected officers and Directors all of whom shall be benefits members and delegates from each local lodge who are not required to be benefits members and the International Officers and Directors from the District.

Cultural Director Gail Martinsen is not present. Since she is a member of the District Board she is technically a member of the District Lodge, however since she is absent she does not count toward the voting members. Therefore, the total number of voting members from the District Board present is 14. Both International Secretary Marci Larson and International Director Ken Johnson are from District 3. So, the total number of voting International Officers present is 2. This concludes the report of the Credentials Committee.

President Andersen asked if there are any questions for the Credential Committee.

Sister Kari announced that there are 78 Delegates, 14 Board members, 2 International Officers, Total: 94 voting members.

Sister Kari **MOVED** on behave of the Credentials Committee to adopt the report of the Credentials Committee. **ADOPTED**.

President Andersen announced that Zone 6 will have a caucus in the corner of the room during the upcoming break. President Andersen asked that everyone return at 10:15 AM

The meeting was recessed at 9:51 AM.

The meeting was reconvened at 10:30 AM.

President Andersen called upon Convention Committee Chairperson Ken Johnson to give any updates.

Brother Ken reported that the cookies for the break were plentiful and good. The issue of long lines for coffee has been addressed with the hotel and will be corrected for future breaks.

President Andersen stated that the Third District Board is authorized by the Third District Bylaws to approve the minutes of the 2016 Convention. The Board did so at its June 2018 meeting. President Andersen called upon District Secretary Karen Olsen-Helmold to read the rules for the meeting.

Sister Karen stated the rules for the meeting. She asked that delegates bring all typographical errors to her in writing at breaks or lunch. Please do not take time on the floor unless it changes the meaning of the report or the resolutions. Any guest who wishes to address the delegation must have approval by the chair before speaking. Roll call will be done each morning and after lunch. Designate one member to respond for your lodge. Please make sure all delegates are seated when the session starts. Do not count anyone who is not in the room. Come to the microphone to be called on. Show your paddle number and wait for the chair to recognize you. Do not shout out comments from your seats during the session. You must come to the microphone so you can be heard.

Sister Karen read correspondence from Districts 1, 2, 4, 5, 6, 7 and 8. The Officers of each District sent their best wishes to District 3 for a successful and productive Convention/Lodge meeting.

Sister Karen read the Roll Call of Lodges with 94 delegates seated; 48 are a majority; 63 are two thirds majority.

President Andersen introduced Parliamentarian Michael Wagner-Diggs. President Andersen stated, "I am pleased to introduce Michael Wagner-Diggs as our Parliamentarian for the 65th Third District Lodge meeting. Michael is no stranger to the Third District, many of you will remember him from Myrtle Beach as well as Virginia Beach."

Mr. Wagner-Diggs will now advise us of the general parliamentary rules of the convention.

Michael read the General Parliamentary Rules for Sons of Norway Third District Lodge meeting June 6-10, 2018 of which each Delegate had been given a copy and **moved** that they be adopted. The motion was seconded by paddle #2 Kathy Dollymore. **ADOPTED.**

President Andersen introduced Nominating Committee Chairperson International Director Marci Larson. Sister Marci is from Gateway to Florida Lodge and was the Chairperson of the 2014 International Convention Committee. As many of you know, the 2014 International Convention was held in Jacksonville Florida.

At this time Marci is going to describe the Nominating Committee process and progress as well as introduce the committee's slate of candidates. Without further ado, I am honored to introduce the Chairperson of the Third District Nominating Committee, Marci Larson.

International Director, Marci Larson Chairperson of the District 3 Nominating Committee

Good Morning everyone. It has been my pleasure to once again serve as the Chairperson of the District 3 Nominating Committee. A process which started in this District in 2016. While it is new to the District level, we are all very familiar with the nominating process at the local lodge

level. So, for most of us it isn't really all that new. I was blessed because the District Board collected an outstanding Nominating Committee and I would like you to meet them. You have probably heard from them during the course of the last few months, but if you haven't let me introduce them to you. International Director Ken Johnson, a member of Henrick Ibsen Lodge, 3D Auditor Kari Brescher, a member from Nor-Bu Lodge, and the fourth member is Deb McConaghy and she was not able to be with us today. As you all know, District 3 extends about 1500 miles along the Eastern Seaboard from Southern Maine to Southern Florida. I think one of the beauties of this committee is that we are from all of the Lodges that are across the District. And when the District Board selected the Nominating Committee they did a really super job in spreading out the representation and the responsibilities. In addition, throughout out the years, we have all been involved at various times with the District 3 Leadership and we have been involved with lodge nominating committees. Just to refresh your memory, in 2014 a By-law change to the Sons of Norway Charter and Constitution, established this new procedure for the nominating and the electing the International Director, the Alternate International Director and the District Board. The purpose of the nominating committee is really very simple, it is to identify, review and submit names of eligible candidates for election to these various positions. The Nominating Committee does not endorse one candidate over another, but rather it is our responsibility to review the candidate's credentials and present all candidates that are eligible as they compare to the position requirements. We started our work last fall by talking with the current Board members to ascertain their interest in the various the Board positions. We have reached out continuously to the Zone Directors to get their assistant in identifying members possibly interest in a leadership position. The Zone Directors were critical as half the lodges went about changing their leadership in January and February. And, they were very instrumental in keeping the message of the Nominating Committee as well as selecting delegates for this Convention. We reached out also to the lodge to encourage sending delegates so that they would have representation. After all, if you are not here, you cannot be heard. So, some of you may ask why this change in the nominating process.

Because of recent legislative and regulatory changes, and in accordance with the best practices of good governance for fraternal benefits societies, it is extremely important that Sons of Norway establish guidelines for anyone seeking election as an officer or director to the International Board and certainly to the District Board. Obviously, a number of members that sit on the District Board will migrate to the International Board. A primary consideration of a potential candidate is if he or she can commit to the time and the flexibility required to fulfill the responsibilities of service. At the last District Convention nominations from the floor remained open until noon on Friday. But that option changed when the International Lodge voted in 2016 to close nominations 30 days ahead of the respective District Convention. While some of you are not fond of this process, it is important to remember that because Sons of Norway sells insurance in 39 states we are regulated by individual state Insurance Commissions and they set rules that we must follow. With all that said I would like to take a few minutes to introduce you to the individuals who have submitted applications for the various Board positions and Zone Director positions. You have received these candidate applications. They were e-mailed to you twice. If you do not have a copy and you would like to review the candidate application, please

see me sometime. I have all the applications with me and would be more than happy to review them with you.

LIFETIME ACHIEVEMENT AWARD 2017

Vice President Kathy Dollymore presented the 2017 Lifetime Achievement Award.

In November of 1992, Helen Timoney placed a small advertisement in the local newspaper. About 20 people showed interest in having a Sons of Norway Lodge in Myrtle Beach, South Carolina. On January 16, 1993, Helen, along with her husband Dan, hosted an afternoon cocktail party at their home for approximately 20 Scandinavians. At this time a committee was formed and with Helen's assistance, and much more work, Southern Star Lodge was formed. On April 23, 1994, Southern Start Lodge #630 was instituted in Myrtle Beach, Horry County, South Carolina with 45 members. Helen Timoney was the first President and Lodge Organizer of Southern Star Lodge #630.

Helen remained President until 1998. At this time, she served as the Counselor and Corresponding Secretary of Southern Star Lodge.

Helen did not contain her Sons of Norway enthusiasm to Southern Star Lodge. From 2000-2004, Helen served as Third District Treasurer. During this time, she modernized the financial process by using the computer to record the information.

Helen left her position as District Treasurer to become the Treasurer for the Land of the Vikings. She served in that position from 2004 until 2010. As if this was not enough to keep her busy, during this time she served as Treasurer for the Third District Convention in Clearwater Florida. When Helen moved to New York, she became a member of Henrik Ibsen Lodge. Here again she did not take a back seat. She was Vice President of Henrik Ibsen Lodge for 2011 through 2012 when she became President, a position she held until 2014. Also, during this same time period, Helen remained active in the District. Meeting recessed at 11:39 AM for lunch.

Thursday afternoon meeting June 7, 2018

President Andersen opened the meeting at 1:10 PM

President Andersen called upon Brother Audun Gythfeldt to lead the delegation in song.

Brother Audun led the delegates in the singing of My Bonnie Lies Over the Ocean.

President Andersen called upon Convention Committee Chairperson Ken Johnson to make the afternoon announcements.

Brother Ken commented that the food has been excellent so far. The bottle neck at the coffee break has been taken care of. The Banquet seating arrangements are on the tables outside of this room. Please sign-up for the table at which you would like to sit. Tonight, dinner is on your own. Brother Ken has the restaurant guide if anyone would like to look at it.

President Andersen called upon Vice President Kathy Dollymore to announce the greeters and the marshals for this session.

Sister Kathy described the jobs of the greeters, marshals and tellers for the first-time delegates. The greeters for the Thursday afternoon session are Pierre Laliberté and Christine Bremseth. The Marshalls for Thursday afternoon are Karen Hansen and Eric Johansson.

Secretary Karen Olsen-Helmold read the roll call of delegates. Delegates totaled 94: simple majority is 48; two-thirds majority is 63.

THIRD DISTRICT LODGE FINANCIAL OVERVIEW

President Andersen called upon Vice President Peter Vatne to review the Third District Lodge Financial Overview. This will be beneficial to the first-time delegates.

Brother Peter handed out a financial overview of the Third District Lodge. Peter gave a Power Point presentation that described the difference between Third District, Third District LTD, the Land of the Vikings Ltd, and Charitable Trust accounts because it could be very confusing. President Andersen called upon Counselor Peter Hanson to talk about the Charitable Trust.

Brother Peter Hanson thanked the delegation for affording him the opportunity to serve as the Third District Counselor. It has given him the opportunity to work with this Third District Board, a group of very dedicated people. Brother Hanson thanked Rannveig Klinge who has served as the Trust Administrator for years and who has handed in her resignation as of now. Sister Rannveig has served for many years and she will be missed. Brother Peter discussed the duties of the position of Counselor and the workings of the Charitable Trust. Brother Peter thanked Scott Tonnesen of Morgan Stanley, our Financial Advisor. Brother Peter also thanked the members for their support in the form of donations. Brother Peter explained the changes in the running of the Trust that will take place due to the suggestions of a committee that was led by Kathy Dollymore and that were approved at the 2016 Third District Convention. Brother Peter asked the Marshalls to distribute to the delegates Resolution B-6 and the change in the verbiage for the explanation of the Charitable Trust which appears after the Third District Bylaws.

President Andersen stated that this Resolution will be referred to the Resolutions Committee.

Paddle # 5 Karen Olsen-Helmold announced that there are two opportunities to support the Charitable Trust during this Convention; the Viking auction tomorrow night and the breakfast at Applebee's on Sunday morning.

Paddle #46 Anita Hoppe suggested that the Charitable Trust entertain accepting donations on line.

MEMBERSHIP REPORT

President Andersen stated that she had asked Vice President Kathy Dollymore to think about three things with regards to membership; a local lodge swat team, a business plan to membership, and a deep dive into our membership data. The swat team was changed to the Local Lodge Support Team with Zone One Director, Stephen Helmold as chairperson, a calling committee was established to call members who were in danger of not renewing. Zone 7 Director Dirk Hanson has embraced analytics. These analytics were used to develop a plan to increase membership.

President Andersen called upon Brother Dirk to discuss the data that he has collected as well as his ideas for recruitment in the form of Satellite Lodges.

Brother Dirk gave a presentation demonstrating what he has uncovered in his research regarding locating Scandinavian people in various parts of the District. Brother Dirk also presented his idea

of having Satellite Lodges that can be part of a host Lodge until the groups are large enough to start their own lodges.

President Andersen spoke of the possibility of using modern technology such as Zoom and Meet-Up Groups to hold leadership training sessions. She also spoke of how Brother Dirk sends out a letter to each member in Zone 7 just before they are due to renew. Dirk shared his letter and program with the other Zone Directors at the last Board meeting.

The meeting was recessed at 2:45 for a coffee break. President Andersen asked everyone to return at 3:15 PM.

The meeting reconvened at 3:15 PM.

GUEST SPEAKERS

President Andersen introduced three guest speakers; International President Jon Tehven, International Chief Operating Officer Christopher Pinkerton and Sons of Norway Foundation Director Corrie Knutson.

International President Joh Tehven introduced the group. President Tehven spoke about the Fraternal aspect of Sons of Norway. He gave a brief history of Sons of Norway and the original purpose of Sons of Norway which is to promote the well being of our members. President Tehven spoke of the Growing to 2020 initiative presently taking place. In 2020, Sons of Norway will celebrate its 125-year Anniversary. It is also hoped that in 2020 the International Lodge will be moving their headquarters back into the new building. President Tehven again recognized those lodges that had 10% growth in 2017.

International Chief Operating Officer Christopher Pinkerton spoke of the Insurance aspect of Sons of Norway. The insurance portion of Sons of Norway is trying to design new products to recruit new members. They are developing plans to contact more existing members and to make sure they reach geographic areas that they have not been reaching with our Financial Benefits Counselors. They are planning to increase the number of our Financial Benefits Counselors from approximately 50 to approximately 100 by the end of next year. They will also be increasing the number of insurance products that are offered to help meet the needs of the membership. There are plans to increase their marketing technics and enhance their website. Chief Operating Officer Pinkerton discussed two of the new products that are now available. Chief Operating Officer Pinkerton also stated that the profits from the insurance portion help to fund the fraternal portion of Sons of Norway.

Sons of Norway Foundation Director Corrie Knutson spoke of the mission of the Foundation which is to support Sons of Norway, its members, and its Lodges. Sister Corrie thanked everyone who has supported the Foundation in the past. She also spoke of the many grants and scholarships that are available from the Foundation explaining how the money was distributed for the past few years. District Three received two grants.

International President Jon Tehven, International Chief Operating Officer Christopher Pinkerton and Sons of Norway Foundation Director Corrie Knutson answered questions from the delegates.

Secretary Karen Olsen-Helmold requested that all unsold flag magnets and money for the sale of the flag magnets from the Third District Fund Raiser be turned into her by the end of the day. Sister Karen explained the Land of the Viking 300 club raffle. Sister Karen has applications for anyone who is interested.

President Andersen requested that everyone be on time for all of the sessions going forward.

The meeting was recessed at 4:30 PM until 8:00 AM Friday, June 8, 2018.

Friday morning meeting June 8, 2018.

President Andersen reconvened the meeting at 8:00 AM. President Andersen called upon Convention Committee Chairperson Ken Johnson to make the morning announcements.

Brother Ken reported on the success of the Excursions that has taken place the last two days. He stated that everyone should have signed-up for a table for the grand banquet. Any questions should be addressed to Banquet Chairperson Susan Olson. There was a mix-up with the placing of tickets for the Viking auction. If anyone thinks that they may have placed their tickets in the wrong color cup should see Viking Auction Chairperson Judy Fleming. The coffee break will be at 10 AM again today in the same room as yesterday. Lunch is also in the Vanderbilt room, the same room as yesterday. Tonight, dinner is on your own.

President Andersen announced that Zone 3 will have a caucus in room 112 at the first Coffee Break. President Andersen then called upon Zone 7 Director Dirk Hanson to give a report on membership numbers.

Brother Dirk gave the results on the May membership numbers. He announced that we are trending upwards over April.

President Andersen announced that International President Jon Tehven has some beautiful King Harold medallions for a \$250 donation to the Humanitarian Fund.

President Andersen called upon Secretary Karen Olsen-Helmold to take the roll call.

Sister Karen read the Roll Call of Lodges with 91 delegates seated; 46 are a majority; 61 are two thirds majority.

President Andersen called upon Vice President Dollymore to announce the greeters and marshals for the morning.

Sister Kathy announced the greeters are Ruth Kornbrekke and Debra Martin and the marshals are Christine Cash and Hank Dester. Sister Kathy asked the greeters to take their paddles and go to the back of the room.

President Andersen called upon Publicity Director Jim Dunagan to discuss the new format for the TDT and the new newsletter contest.

Two delegates from Fredheim arrived. There are now with 93 delegates seated; 47 are a majority; 62 are two thirds majority.

Brother Jim gave a presentation of the results of his Committee's findings regarding a new format for a Public Relations contest. Using District Six as a model, there will be a Communications award which will recognize all forms of communication and which will be given to any and all Lodges that get a certain number of points based on a multi-media plan.

Counselor Peter Hanson reminded everyone that there is a \$10.00 penalty that goes to the Charitable Trust each tine a cell phone rings.

President Andersen stated that she is going to start calling up the committees. The committees will present the resolutions assigned to them and provide their recommendations. Since it is a Committee, no second is needed. This is your opportunity to share your view. Remember to approach the microphone, show your paddle with the number facing the Secretary, state your name and your lodge. Speak only to the issue being debated. Personal, accusatory, or libelous statements will not be tolerated. You will have two minutes to speak to the issue. You cannot speak twice to the same issue.

President Andersen called upon the Law Committee to present the Resolutions assigned to them.

Chairperson Barbara Bensen from Noreg Lodge introduced the committee members; Miki Ryan from Bernt Balchen Lodge and Peter Evensen from Gateway to Florida Lodge.

Resolution 4 International Director and Alternate Submitted by District Lodge #3 Board

WHEREAS, paragraph 2.6.1 of the Sons of Norway Constitution specifies that the District President shall be one of the Delegates to the International Lodge meeting; and

WHEREAS, paragraph 3.7.3 of the Sons of Norway Constitution specifies that each District shall establish Bylaws governing the manner of election of International Delegates and Alternates; and

WHEREAS, the Third District Bylaws do not ensure that the nominated International Director, nor the Alternate, will automatically be one of the Delegates to the International Lodge meeting;

THEREFORE, BE IT RESOLVED that the following new section be added to Article X of the Third District Bylaws:

8. The nominated International Director, as well as the Alternate, shall be Delegates to the International Lodge meeting.

Resolution 6 Silver Membership Submitted by Norumbega Lodge #3-506

WHEREAS, members near the end of their life often give up membership in Sons of Norway due to illness or other extenuating circumstances; and

WHEREAS, such former members are not remembered by name in the Viking Magazine or at District, Zone, or Lodge Memorial Services when they pass away; and

WHEREAS, this seems especially wrong for such former members who prior to Jan. 1, 1999 would have qualified for Life Membership;

THEREFORE, BE IT RESOLVED that paragraph 1.6.1.9 be added to the Sons of Norway Charter, Constitution Policies and Procedures:

1.6.1.9. Silver Members - Members who are no longer in good standing with Sons of Norway with respect to dues but had previously been members in good standing in the Order for 30 years or more, shall be classified as Silver Members. Such members shall not have any voting or representation rights in Sons of Norway, nor any other membership benefits, such as receiving the Viking Magazine, but shall be welcomed at Lodge meetings, and shall be remembered in the Viking Magazine and at District, Zone, or Lodge Memorial Services when they pass away.

Resolution 7 District Nominating Committee Submitted by Norumbega Lodge #3-506

WHEREAS, this restriction prevents Zone Directors from serving on the Nominating Committee, unless they are completely retiring from service on the District Board; and

WHEREAS, of all the District Officers and Directors, Zone Directors are the closest in touch with the Local Lodges, and therefore make ideal members of the District Nominating Committee; and

WHEREAS, Robert's Rules of Order recommends that members of the Nominating Committee not be barred from becoming nominees themselves (excluding the current President), as such a requirement deprives its members of one of their privileges (see pg. 433, lines 29-35);

THEREFORE, BE IT RESOLVED that Paragraph 3.11.5.1 of the Sons of Norway Constitution be amended by replacing the sentence "No member of the Nominating Committee shall be a candidate for election as District Lodge Officer or Director." with "No member of the District Executive Committee shall be a member of the Nominating Committee."

WHEREAS, some lodges are unable to fund or partially fund the cost for delegates to attend the convention and do not have any members who can take on the financial liability of attending, and

WHEREAS, lodges that cannot send a delegate should still have a voting voice at the convention.

THEREFORE, BE IT RESOLVED: That Chapter 9 para 1.9.1 Proxy Voting of the Charter, Constitution Policies and Procedures be amended to read:

"Each member of the District Lodge shall be entitled to one vote, and each local lodge not in attendance shall be entitled to one proxy vote, subject however, to the following: The elected delegates and proxy votes shall always have at least two thirds of the votes and in the event the Officers and Directors of the District and International Lodges (who are not elected delegates) shall exceed one third of the total number of members and proxy voters present entitled to cast votes, then such members shall not be entitled to cast more than 1/3 of the total number of eligible votes that could be cast at such District Lodge meetings.

FURTHER BE IT RESOLVED: Charter, Constitution Policies and Convention Chapter 9 Para 3.9.1.2 Proxy Vote Rules be added to read as follows:

"Each District shall be responsible for setting proxy vote protocols"

Financial Impact: None

The Resolution was withdrawn by Leonard Zingarelli, President of Hampton Roads Lodge because Minnesota Law will not allow proxy votes.

Resolution 15 Nominations for District Officers from the Convention Floor Submitted by Norden Lodge 3-407

WHEREAS, District Lodges have always had candidate nominations from the floor at prior District Lodge meetings; and

WHEREAS, at previous District Lodge meetings candidate nominations were accepted without prior knowledge to neither the District Board nor the District Nominating Committee; and

THEREFORE, BE IT RESOLVED, that the District Lodge President/Chair be allowed to accept candidate nominations form the floor at the District Lodge meeting and to merge those nominations into the roster from the nominating committee; and

BE IT FURTHER RESOLVED, that paragraph 3.11.5.1.1 of the Sons of Norway Constitution be amended to read (deleted text struck through, added text underlined):

3.11.5.1.1 Candidate applications for District Officers must be submitted to the Nominating Committee for vetting no later than 30 days prior to the start of the District Lodge meeting. (8/16). <u>Candidates for District Office may also be nominated from the floor at the District Lodge meeting</u>. These candidates will be merged into the roster from the nominating committee.

WHEREAS, members are scattered across the country and often do not update their addresses; and

WHEREAS, many members have paid dues for 30, 40 or even 50 years of membership.; and

WHEREAS, many older members spend their final days in a medical facility such as a nursing home or rehabilitation center and do not receive their notice to pay dues: and

WHEREAS, in many cases there is no way to find the next of kin of these members; and

WHEREAS, these members are cancelled for lack of payment of dues; and

WHEREAS, it would be beneficial to the member and the Order to keep the membership active as well as the fraternal thing to do;

THEREFORE, BE IT RESOLVED that the Sons of Norway application for membership be revised to include a line for an emergency contact. AND

THEREFORE, BE IT FURTHER RESOLVED that the dues renewal statement include a line for an emergency contact. AND

THEREFORE, BE IT FURTHER RESOLVED, that this emergency contact information be included on the membership lists provided by the Home Office.

FINANCIAL IMPACT There is no cost to change the on-line application. There is also no charge to start to print new membership applications with the addition of an emergency contact number the next time membership applications are printed. It might take a little time to input the emergency contact information on the membership list, however this amount and more would be saved by not sending the Viking Magazine.

President Andersen called upon Brother Audun to led the delegation in song.

Brother Audun led the delegation in the singing of Hils Fra Meg Der Hjemme.

LOV BOARD'S REPORT

President Andersen called upon Land of the Vikings Chairperson Roy Berntsen and the LOV Board to update the delegation on The Land of The Vikings.

Land of the Vikings Chairperson Roy Berntsen introduced himself and his board; First is Helen Timoney – our new Lifetime Achievement Award Winner and my Treasurer. Next, I would like to introduce our new Marketing Chairperson Elisabeth Nilsen. To my left is Barbara Berntsen our Secretary. Not with us today is; Vice Chairperson Billy Karpack, Buildings and Grounds Chairperson Rick Budrick, our Manager Beverly Budrick and our Facebook Administrator Maureen Cooper.

Brother Roy read the following report:

I would like to talk to you about our "home away from home, LOV." I remember a good friend of mine and the LOV Board's Alf Kristian Rasmussen stated at the last convention: "the \$2.00 Fraternal Fee was for the Third District Ltd. to pay the taxes and liability insurance. The LOV operations group was to pay to keep the lodge going, paying bills and the upkeep of the property."

You see we were short of being profitable but we were responsible for paying back taxes and still some bills from before they closed the doors back in 2013. We are still working to gain our reputation as a business that does not neglect our bills.

LOV Secretary Barbara Bernsen discussed the Liquor License and what took so long to have it approved. Sister Barbara gave the following report "The PLCB received the payment, but the back taxes needed to be completely redone. She thanked Peter Hanson for his assistance in getting that completed, but it took another three months to find out why the license was not granted by the PLCB. After calling three times each week and finally getting to a supervisor – who stated she did not know how to fix this problem – and more calls, finally she found a person who would reinstall all the tax payments and figures into the computer. What happened was the tax department went to an on-line program, gave LOV a new account number and never notified us or LOV. After another time, when the tax payments were installed into the new account, Barbara had to redo the 2016 tax forms and send them to the supervisor. After another week of calls, it was finally updated completely and, on her birthday, – December 30th – the license was approved and we did not have any additional charges (we did have a late charge of \$150 in October as they did not approve the license yet) since we already paid the late fee --- BUT we did lose three months' worth of revenue. The liquor distributor told Rick that their change to electronic applications were major problem in Wayne County and many of the business and bars still did not have their license. I guess it paid to be a pest."

Brother Roy continued that LOV has changed the way they have weekend events. No longer does a lodge have to rent the place for a weekend. As lodges got smaller and members got older many lodges cannot have send enough people to make the weekend profitable for LOV. Now,

we are hosting events that are open to everyone. Lodges are still welcome to use LOV for individual lodge weekends, but in between we will have more joint events.

Brother Roy continued with his report," At the last board meeting Rick and I presented to the Third District Ltd. Board the possibility of earning approximately \$20,000 into their account. That is the account which pays for the taxes and the liability insurance. We spoke with a lumberer who would remove the dead trees to allow the young trees to grow. We hope the committee to review this project would look into this seriously. We will make sure the contract will state all our requests before it is signed.

Brother Roy stated that the positions on the LOV Board are appointed positions. If the new Third District Board would like him to continue to run LOV he would be happy to remain as the Chairperson. However, if the Board should vote to sell LOV, he will not continue as Chairperson.

Brother Roy explained the benefits of LOV as a Cultural Center, it is used to store all of the Third District items. It is used for Youth Camp which is a way to get our youngsters involved in Sons of Norway. LOV is being used by other groups also to help keep it open for our use.

Brother Roy called upon Elisabeth Nilsen to alert everyone to what is coming up. (Elisabeth read the list of upcoming activities handed out.)

As you can see from the Events Calendar that you all received in your bags LOV has a lot of activities on the books. We can always use more events. Please come and enjoy yourself at one or more of these weekends.

Brother Roy continued with his report," We are also planning future fundraisers to help us during the mud and Christmas seasons. We are doing fundraisers just as all the lodges, the district and the Charitable Trust does as they execute their own fundraisers." April, May and December are slow months. We welcome any ideas to increase business during these months.

Brother Roy thanked everyone for their support, especially for all the donations that were received when LOV was in the process of reopening.

LOV Treasurer Helen Timoney thanked Brother Peter Hanson for assisting in the back-tax issue and Peter Hanson and Peter Vatne for redoing the chart of accounts in the Quick Books Program. She also thanked her right-hand woman Shirley Erland for all her help during the year getting the account up to standard and for her thinking out of the box.

President Andersen reminded Zone 3 of their caucus meeting in room 112 during the break and asked the judges for the Cultural Arts Competition to meet with her at this time in the front of the room.

Meeting was recessed for a coffee break until 10:15 AM.

Meeting reconvened at 10:20 AM.

President Andersen called upon Convention Committee Chairperson Ken Johnson to make announcements.

Chairperson Ken Johnson **moved** that the coffee breaks be extended by no longer than 10 minutes. Motion seconded. **CARRIED.**

An Unge Venner member who desires a subscription to the Viking Magazine, will be assessed the same amount as is allocated to the Viking Magazine subscription in the annual adult membership.

The Charter may be kept open for $60 \ 90$ days after the institution of a new Lodge.

Resolution 2 Number of Delegates per Local Lodge 65th District Convention Minutes June 6-10, 2018

Each Local Lodge may elect an equal or greater number of Alternates (paragraph 4.7.1). All persons who have been members of the Order for at least three months shall be eligible for election as Delegates or Alternates.

Financial Impact Statement

Estimated Amount: \$200. This represents the extra cost for binders and certain printed materials at the convention.

No other District costs would increase, as each additional delegate pays their own package and hotel.

There will be an additional cost to local Lodges that subsidize their delegates in whole or in part.

Means by which Funds are Obtained: Funds would come from existing dues. The estimate is conservatively high, and the cost divided by the number of members in the District comes to about \$0.05 per member.

Resolutions committee moved tabling or postponing this resolution until the next convention in 2020.

WHEREAS, transparency of all actions is very important to the order, especially in maintaining membership, and

This was at a time when the assumption was that the gas on the property could be gotten and sold.

In 2014, President Andersen contacted the same brokerage firm and the value was between \$700,000 to \$800,000. Brother Paul then contacted real estate investors and finally dealt with an abstract company that was able to find all of the comparable properties that have been sold and there was one very similar with 150 acres that was sold this past February for \$430,000. Brother Paul then contacted the Real Estate Agency which was in Hancock who sold that piece of property and they valued Land of the Vikings at possibility \$600,000. They said that there are no comparable properties. Most of what is available are camps with a lake. Brother Paul stated

that after all his research, in his opinion if we wanted to sell Land of the Viking quick, you are probably looking at approximately \$500,000. They all admit that they are guessing since there are no comparable listings. Some have been on the market for over two years. Also, if the buyer wants to use the building there will be code issues to deal with.

President Andersen recalled the Finance Committee.

The Finance Committee examined the District Lodge No. 3 Sons of Norway Budget on page 66. The Committee recommended that for the 2020 budget, the \$21,600 that was allocated as Dues to Support LOV transfer be reallocated to a new category of Lodge Support and Member Growth.
