MEMORIAL SERVICE, FRIDAY, JUNE 10, 2022, 5:00 PM

The Memorial Service was held at the hotel. As guests entered, prelude music was played on a keyboard by Gateway to Florida Lodge member Bonnie Hardman. Guests also received two booklets - a program for the service and a listing of those who have passed in the seven Zones of District 3.

At 5:00 PM, Sons of Norway International Secretary Marci Larson welcomed everyone to the 66th Third District Lodge Meeting and Convention Memorial Service. Reverend Ida Iverson of Gateway to Florida Lodge followed by giving an invocation. Rannveig Klinge of Nordkap Lodge recited the 23rd Psalm in Norwegian, and Reverend Ida read from Scripture 1 Corinthians 15:50-58.

Reverend Iverson sang a hymn called "Hymn of Promise", and Third District International Director, Ken Johnson, gave a tribute afterwards.

The Memorial Address was given by Third District President Kathy Dollymore and was as follows:

Welcome and thank you for coming to the Third District Memorial Service. Your presence here matters. Looking around the room today I see many familiar faces, as well as some new ones. This isn't surprising to me as the love in our Sons of Norway family flows strong and deep leaving us memories to treasure.

Today we are holding this Memorial service for the Sons of Norway Third District members who have passed away in the past 4 years. We know it helps to share with others who understand and care about our sorrow and know that God's love and power extends all over creation.

Today we think of the Brothers and Sisters we've lost, but this is not unusual because so much of them lives on in our memories.

Each member is a treasure to our Lodge, Zone, District and to the Order. We recognize their achievements and welcome those friendships by remembering them this afternoon. They played an important role in all our lives. I can confidently say everyone here probably has a story about a time a lodge member helped or supported us. Their face comes clearly into focus, we hear their wise counsel and see their laughing eyes. A song, a word, a smile, and our world is a better place. "A.A. Milne once wrote, 'If there ever comes a day when we can't be together, keep me in your heart, I'll stay there forever.'

It is understood that people have to mourn and grieve, each in their own way, but what we are thankful for is the family and friendships formed in our order. The joys of fellowship and high ideals like beacons guiding us through life. Today we are celebrating life. So, I would ask everyone here to take a minute to reflect on all the happy and joyful moments, the love, the laughter, and funny antics which they brought to all our lives. Hold that in your heart and mind. For today while in the company of each other, we celebrate the memories and life of these individuals.

Nothing truly good is ever lost, and love never dies. The gifts of love and goodness will be passed along in our unending circle of life, and we will hold them in our hearts always. Here is a poem by Christy Ann Martine.

A procession of Zone Directors carrying candles followed the address. This included: Zone 1 Director Elaine Breiland, Zone 2 Director Peter Hanson standing in for John E. Foss Jr., Zone 3 Director Audun Gythfeldt, Zone 4 Director Kaare Hansen, Zone 5 Director Arnie Johnsen, Zone 6 Director Marie Hansen, and Zone 7 Director Dirk Hansen. To pay tribute to those who have died, President Kathy Dollymore lit each Director's candle in order and stated, "I would like us to remember all the members who have joined Lodge Eternal from Zone __." She then extinguished each candle in order while saying "I would like to honor those members who have joined Lodge Eternal from Zone __." Zone Directors were asked to be seated among the guests. All joined in singing verses 1, 3, and 5 of "Amazing Grace", and Reverend Ida Iverson gave the Benediction sharing two verses from Scripture.

Isaiah 40:31, "He gathers the lambs in his arms and carries them close to his heart.", and John 14: 1-2, "Let not your heart be troubled: ye believe in God, believe also in me. In my Father's house are many mansions: if it were not so, I would have told you. I go to prepare a place for you."

Bonnie Hardman played a postlude on her keyboard as all guests exited.

A light buffet dinner was held in the hotel room next to the outdoor pool. Convention Advisor and International Secretary Marci Larson welcomed all delegates, non-delegates, Board members, Gateway to Florida Convention Committee members, and International Director Ken Johnson to the reception. Colors abounded, since so many were wearing casual Hawaiian flowered shirts. Marci introduced President Kathy Dollymore. THIRD DISTRICT LODGE MEETING, SATURDAY, JUNE 11, 2022, 8:00 AM

This meeting was held jointly by Board members, lodge delegates, and International members who were either attending at the Doubletree Jacksonville Hotel or on an electronic (virtual) platform called ZOOM.

President Kathy Dollymore called the meeting to order at 8:04 AM. She used her gavel and shared the history of the Third District's Traveling Gavel. She said the wood used to make it was over 1000 years old and was from a Viking ship. A former member carved the wood. The Gavel will be going from lodge to lodge in the future.

All rose for the singing of the Canadian, Norwegian, and American anthems, followed by the Pledge of Allegiance. President Dollymore began by thanking Convention Advisor Marci Larson and her Convention Committee for all their work over the years of 2018 to 2022. All were applauded. Counselor Peter Hanson reviewed the \$10 donation rule. If someone's cell phone goes off during the meeting, they owe the Third District Charitable Trust \$10.

At 8:20 AM, President Dollymore excused the Convention Credentials Committee (Chairperson Arnie Johnsen, Peter Hanson, and Marie Hanson) to perform their work.

She introduced the former District and International officers present, announcing their highest rank, and asked them to wave.

They were applauded.

President Dollymore welcomed all to the beautiful Jacksonville area and asked us to relax and meet other delegates. She asked that we attend all sessions of the meeting and carefully consider

the resolutions. She said we are trying something new having a shorter business meeting and having some delegates attend virtually and asked that we treat all delegates and the members in our lodges at home with respect and dignity. She noted that declining membership is a problem in the organization and asked we try to bring in at least one new member. Finally, she asked us to stick to the time schedule of the convention.

CREDENTIALS COMMITTEE

Chairperson Arnie Johnsen introduced committee members Peter Hanson and Marie Hansen. All lodge delegates, all Board members, the International Secretary, the International Director, and Parliamentarian received a copy of the 66th Convention Reports Book from Secretary Jeanne Addison prior to the meeting. Arnie announced the following changes to the Reports Book:

- 1) p. 3 Njaal and Alice Svege from Brooklyn Lodge will no longer be delegates. (Later information informed the Committee that Alice would be a virtual delegate.)
- 2) p. 4 Kit Gannon of Gulfstream is changed to "Frances Gagnon" (on delegate report form she was listed as Kit Gannon)
- 3) p. 4 Jerry Blau of Hampton Roads is now virtual
- 4) p. 7 Sonia Forrest and Cara Lee Blume of Restauration will no longer be delegates
- 5) p. 7 Constance Koprowicz and Gladys Hyland of Southern Star will no longer be delegates
- 6) p. 11 Public Relations Director Jim Dunagan is a non-voting member
- p. 11 recommend that International Secretary Marci Larson (Gateway to Florida Lodge) should be listed also

The chart reflects 78 Lodge Delegates. There are also 16 Board members and 2 International officers seated at the time, for a total of 96. One Board member, PR Director Jim Dunagan, is non-voting (appointed to his position). The total number of voting members is 78+15+2=95. With those changes, Arnie also announced that there are 59 in-person and 36 virtual voting members for a total of 95 voting members.

Motion: Chair Arnie Johnsen made a motion, on behalf of the Credentials Committee, to adopt the Credentials report on pages 3-8, as corrected. President Kathy Dollymore said that since it is a motion from a committee, a second is not required.

Jim Mostrum (Paddle # 92) said he only sees 33 virtual attendees on the screen.

Barbara Berntsen (Paddle # 20) said to remember that, if a vote comes, the attendance is checked then.

Barbara and Karen Olsen-Helmold (paddle #71) noted that Michael Pedersen (paddle #88) and Melissa Pedersen (paddle #87) of Loyal Lodge just joined the meeting.

APPROVED By a show of paddles, the Credentials Committee's report as corrected was approved. No one opposed.

Kathy excused the Credentials Committee with thanks for their work.

APPROVAL OF 2018 CONVENTION MINUTES

President Dollymore announced that "the District Board is authorized by the Third District Bylaws to approve the June 6-10, 2018, Convention Minutes on behalf of the District Lodge". The Board did so at its October 27, 2018, Board meeting.

GREETERS, TELLERS, MARSHALS

Vice President Steve Helmold assigned the following:

CONVENTION MEETING GUIDELINES

Secretary Jeanne Addison read the District Lodge Meeting Guidelines. In short summary, they stated: bring all typographical errors to the Secretary at breaks, be approved by the Chair before speaking, be on time for roll in the morning and after lunch, have one delegate from each lodge respond to roll, show your paddle whether in-person or on ZOOM then be recognized by the Chair before speaking, shout no comments during the meeting.

ROLL CALL AND SECRETARY COMMUNICATION

Secretary Jeanne Addison read the Roll Call of Lodges for the Day 1 AM list of Lodge Delegates. At the time, all delegates were present. Thus, there were 78 lodge delegates, 16 Board members, and 2 International officers seated for a total of 96. Voting members seated were 95. Jeanne asked everyone to put their name on all papers, in case of loss.

PARLIAMENTARIAN

President Kathy Dollymore introduced the Parliamentarian, Roger Winslow. Roger thanked all for inviting him and asked that everyone respect each other.

These Parliamentary Rules were read by President Dollymore who then explained that part of today's business would be to complete the ballots for International delegates.

Motion: Peter Vatne (Paddle #46) moved to approve the General Parliamentary Rules as read.

Seconded: Christine Taylor (Paddle #49) seconded.

APPROVED By a show of paddles, all approved. No one opposed.

Before bringing up further committees, President Dollymore thanked all committee members for serving.

LAND OF THE VIKINGS (LOV)

President Kathy Dollymore invited Roy Berntsen, Chair of the Land of the Vikings Board, and Barbara Berntsen to speak. Both are members of Norden Lodge. Roy introduced the members of the Board: Vice Chair Billy Karpack, Building & Grounds Rick Budrick, Secretary Barbara Berntsen, Treasurer Karen Olsen-Helmold, Marketing Director Elizabeth Nilsen, and Manager Bev Budrick. President Dollymore thanked Roy, Barbara, Karen, and Elizabeth, who were all participants in this meeting, for their work over many years.

Roy explained that after LOV had been closed for several years and in some disrepair, District President Mary Andersen discussed trying to open it again. Repairs were made, and LOV Board members worked constantly for many years trying to maintain the facility, fundraise, and attract Sons of Norway members and non-members as customers. For several years, Land of the Vikings was "in the red" economically. Roy said that in its last year of operation (2019) LOV was "in the black", especially due to the efforts of Karen Olsen-Helmold. He said, though, it was going to be very hard to keep it that way for years to come. The LOV Board made a proposal to the Third District Board to close LOV again. The alternatives, he said, might be a fire sale or LOV being taken for taxes. At the end of 2019, the LOV Board decided to stop operations. The Third District Board agreed with the decision. Plans were then made to sell the property. In hindsight, it turned out to be a good decision because the pandemic followed. Barbara added she and Roy checked on the property so many times. Bills in the winter were difficult to afford. Both agreed that when Karen Olsen-Helmold shared the good numbers from 2019 with the purchaser, it helped in the final sale of the property. Roy thanked the LOV Sale Committee chaired by Vice President Steve Helmold. Steve said they were happy with the final sale price and that the new owners have had to do some repairs since the sale.

President Kathy Dollymore then asked everyone at the meeting who had done a work weekend at LOV, been involved in Youth Camp, been on the LOV Board, donated to improvements at LOV, or enjoyed times at LOV to please stand. All were applauded.

Vice President Stephen Helmold added that the other LOV Sale Committee members were Karen Olsen-Helmold, Paul Kornbrekke, and Elaine Breiland. He thanked Roy for showing the property at times, too. The LOV Sale Committee members were applauded.

REPORTS COMMITTEE

President Kathy Dollymore called forward the committee. Chairperson Christine Taylor (Suncoast) introduced the other members - Arvida "Chris" Cash (Nordkap) and Lorin Johannessen (Hudson Valley). The Committee reviewed the entire 2022 Convention Reports Book. Chairperson Christine Taylor made us laugh when she told us that it was ironic that the only delegate name in which Secretary Jeanne Addison made a mistake was her name (Talyor instead of Taylor), the Reports Committee Chair's name. Christine stated:

- 1) Chris Cash reviewed pp. 1-13 of the Reports Book and the cover. Chris recommended correcting Christine Taylor's name on p. 9 and then all would be in order.
- 2) Christine Taylor reviewed pp. 27 154. Christine noted that between pp. 148 and 149, the page with the officers from 1924 1938, is missing. The current and past District Secretaries are working on locating it. Otherwise, all was in order.
- 3) Lorin Johannessen reviewed pp. 14-26 and the District President's message and said that all was in order.

Motion: The Reports Committee recommended approval of the Reports Book. **APPROVED** By a show of paddles, all approved. No one opposed.

THIRD DISTRICT CHARITABLE TRUST

President Kathy Dollymore called Counselor Peter Hanson to speak. Peter said in 2018 there was a change in bylaws that made the Trustees of the Charitable Trust individuals who were the Counselor and 4 others, not the Counselor and the other Third District Executive Committee members. The Trustees presently are Peter Hanson (Chair), Peter Vatne (Financial Administrator), Doris Beck, Judi Nilsen Mack, and Audun Gythfeldt. Peter said they are advised by Scott Tonnessen of Morgan Stanley. Over the 6 years that Peter served, there have been 3

beneficiaries at a time receiving monthly checks from the Trust. These beneficiaries are struggling financially. Lodges have made recommendations on individuals, but some applicants have not followed through due to public assistance rules. The Morgan Stanley investment portfolio has grown from \$154,000 in 2016 to \$321,000 in 2022. Dividends, interest, donations, and some sale of portfolio items help to fund the beneficiaries' payments. Peter Hanson said he is retiring from the Trustees, and he was honored to do the work. He encouraged lodges to place a line-item in lodge budgets for the Trust as well as check out www.3dsofn.org under Charitable Giving to get more information and to donate.

The meeting recessed for a coffee break at 9:49 AM and resumed at 10:23 AM.

President Kathy noted that copies of the Parliamentary Rules were available for those who needed them. Marshalls handed them out.

Marty Iverson (Gateway to Florida, paddle # 27) announced that Gateway's alternate delegate, Evelyn Hopkins substituted for Kent Larson (paddle # 28).

CALLING UP COMMITTEES

President Dollymore reviewed the protocol for all delegates when the Law, Resolutions, and Finance Committees come forward. She noted that when committees give a recommendation and make a motion to adopt or reject, no second is needed. In-person delegates should approach the microphone with their paddle, and virtual delegates should raise their hand on the screen. When the Chair recognizes the delegate, he or she should state his or her name, lodge, and paddle # and speak only to the issue being debated. Personal, accusatory, or libelous statements will not be tolerated. Each delegate will have two minutes to speak to the issue and cannot speak twice to the same issue.

Karen Olsen-Helmold (paddle # 71) announced that Alice Svege (Brooklyn, paddle # 96) just joined the meeting virtually. Brooklyn Lodge now has 2 delegates. That makes the total voting members 96 with 49 as a majority and 65 as a 2/3 majority.

LAW COMMITTEE

President Kathy Dollymore called the Law Committee forward. Chair Peter Vatne (Norumbega) introduced the other members - Owen Christianson (Washington) and Jerry Blau (Hampton Roads).

Resolution #1

Counselor/Charitable Trust Director Submitted by District Lodge #3 for District Bylaws

Peter Vatne presented this resolution.

WHEREAS members of the Executive Committee are no longer trustees of the Charitable Trust, **WHEREAS** the Counselor in later year has essentially only had as his/her responsibility to chair the meeting of the Charitable Trust trustees, and

WHEREAS Charitable Trust trustees are elected by the District Board from non-board members,

ARTICLE VI

DUTIES OF OFFICERS

- 3. The Counselor shall:
 - a. Propose and initiate measures and actions to achieve high performance standards with respect to the ceremonial activities of the District Lodge and Local Lodges; and
 - b. Serve as a Trustee and the Chairperson of the Charitable Trust Fund.

THEREFORE, BE IT RESOLVED that the position of Counselor be renamed Charitable Trust Director who shall be a member of the District Board but not a member of the Executive Committee.

FINANCIAL IMPACT: The cost of hosting the Charitable Trust Director for extra overnights at the Executive meetings would save District funds at two District 3 Board meetings and the Convention/Meeting.

Motion: Peter Vatne moved on behalf of the Law Committee to substitute Resolution #1. **ADOPTED.**

Motion: Peter Vatne moved on behalf of the Law Committee to divide Substitute Resolution #1 into Part A and Part B. These parts will bring a vote for removing the Counselor position from the Executive Committee and a vote to change the name of Counselor to Charitable Trust Director and simplify the duties.

ADOPTED

Substitute Resolution #1: Part A

WHEREAS members of the Executive Committee, except the Counselor, are no longer trustees of the Charitable Trust, and

WHEREAS Charitable Trust trustees are elected by the District Board from non-board members,

THEREFORE, be it resolved that the position of Counselor be removed from the Executive Committee.

Motion: The Law Committee recommended adoption of Substitute Resolution #1, Part A. **PART A DEFEATED.**

Substitute Resolution #1: Part B

WHEREAS the Counselor in later years has essentially only had as his/her responsibility to chair the meetings of the Charitable Trust trustees, and

WHEREAS Charitable Trust trustees are elected by the District Board from non-board members,

THEREFORE, be it resolved that the position of Counselor be renamed Charitable Trust Director, and the position's duties simplified.

ARTICLE V

4.6. MEMBERSHIP ADMINISTRATION

Resolution # 17

Special Award for President, Vice President, Secretary, and Treasurer Submitted by District 3 Law Committee and District 3 Finance Committee for Special Award

Peter Vatne presented this Resolution not seen by the delegates prior to the Meeting.

WHEREAS the President and Vice President are not currently compensated by the District; and WHEREAS the President and Vice President, as well as the Secretary and Treasurer, have had to work extra hard during the sale of Land of the Vikings and during the Covid-19 pandemic; and

WHEREAS the incoming President, Vice President, Secretary, and Treasurer will be compensated \$1250, \$500, \$1000, and \$500 per year, respectively,

THEREFORE, be it resolved that the current President be awarded \$1250, the current Vice President be awarded \$500, the current Secretary be awarded the difference between \$1000 and her compensation for the period 7/1/2021 to 6/30/2022, and the current Treasurer be awarded the difference between \$500 and her compensation for the period 7/1/2021 to 6/30/2022.

FINANCIAL IMPACT: Approximately \$2500 in one-time payments.

Motion: Peter Vatne moved on behalf of the Law Committee to bring this resolution to the floor.

Motion: The Law Committee recommended adoption of Resolution #17.

ADOPTED

President Kathy Dollymore excused the Law Committee and gave thanks to them for their work.

CHARITABLE GIVING GROUP

President Dollymore invited members of the group, Chairperson Dirk Hansen, Audun Gythfeldt, and Kaare Hansen, to give a report. Another member, Peter Hanson, already spoke about one of the group's fundraising causes, the Third District Charitable Trust. The other two causes are the Sons of Norway Foundation and Alzheimer's support.

Dirk Hansen stated that two other individuals have been very involved in the Giving Group over the last few years, and he thanked them. They are: Public Relations Director Jim Dunagan, who helped with the 3D website, and Kimberly Breiland, who helped with e-mail blasts. Dirk also announced that June 20 is the Alzheimer's Association's Longest Day Campaign. He created an email with a link for donating to this. There is a District newsletter contest that encourages lodges to put a statement in their newsletter heading saying "_____ Lodge supports a dementia-friendly society". There is a raffle at the Convention Banquet for a quilt donated by Gateway to Florida Lodge which will benefit the Charitable Giving Group. He said that our District can do even more good work by donating to these causes. Audun Gythfeldt spoke about how Alzheimer's had affected his family. His Nor-Bu Lodge raised \$4000 last year with a walk for Alzheimer's, and the lodge intends to create a "memory café" where those afflicted with and/or impacted by Alzheimer's can stop for a chat and refreshments. Kaare spoke about the fact that Dirk has been a great leader and asked members to not delete emails from Dirk. Kaare participated in 2 local Alzheimer's Walks which were very rewarding to him personally. He said he enjoyed being part of the Third District Charitable Giving Committee.

President Kathy Dollymore thanked all the members of the Charitable Giving Group. All were applauded.

The meeting recessed for a coffee break at 2:58 PM and resumed at 3:25 PM. President Dollymore suggested delegates stop at the Cultural Exhibit and Viking Auction rooms.

Alternate Gateway to Florida delegate Evelyn Hopkins substituted for Kent Larson (paddle #28).

SONS OF NORWAY GOVERNANCE

President Dollymore introduced International Secretary Marci Larson, Third District International Director Ken Johnson, and Sons of Norway Director of Fraternal & Foundation Connie O'Brien. Ken said he enjoyed working as the District's International Director for the last 6 years.

Ken then reported that on Sept. 27, 2021, a new form of governance for Sons of Norway was put forth, voted upon, and approved virtually by International delegates. It was then submitted to the State of Minnesota Department of Commerce on Oct. 29, 2021, for approval. There is now a waiting period. He introduced Connie O'Brien who prepared a PowerPoint presentation entitled Sons of Norway Governance to show delegates. Connie began her talk with an exercise to reverse the way we fold our hands, asking all to try change. In the Powerpoint, the following topics were covered: the history of Sons of Norway as an insurance and fraternal benefit company, membership growth of 62% in 2018-2022, the fact that new insurance products helped promote growth, how insurance sales do not show a profit for 10 years since they are long-term products, and recent increased recruiting of insurance agents by Sons of Norway. She added the new governance should not affect District conventions and would be finalized in the Charter, Constitutions, and Policies & Procedures and placed on the website as soon as possible. She also said that the next International Convention would be virtual and held August 31-Sept. 1, 2022.

President Kathy Dollymore thanked Connie, Marci, and Ken for their work.

TREASURER STATEMENT

Treasurer Kari Williams said that she would be retiring at the end of her term. She thanked Peter Vatne for his help over the 4 years. All financial reports from 2018-2022 are in the Reports Book. Kathy Dollymore thanked her for her fine work on the District Board for so many years.

FINANCE COMMITTEE

President Dollymore stated that the Committee would only be discussing the 2020 and 2021 financial reports and the budget. All 2018 and 2019 financials were audited and previously approved by the Board. Prior to this meeting, all delegates were sent the Reports Book by Secretary Jeanne Addison with 2018-2021 Financials and the 3D Budget on pp. 48-111. Delegates were also sent a corrected p. 101 since the original p. 101 was missing a line item for "Donations".

The Committee was called forward. Members were Chairperson Greg Ovrebo (Washington), Patricia Hansen (Nørrona), and Harriet McHenry (Gulf Coast Vikings). Greg noted that there were 4 audits for the years 2018-2021. He then reviewed the following financial reports for approval:

WHEREAS the people of District 3 are dismayed at the lack of transparency regarding the "Sons of Norway Referendum 2021" which was brought forward at a time when the normal functioning of Sons of Norway had been adversely affected by the Nation's Health Emergency, **THEREFORE**, be it resolved that a complete, fully described Governance Plan shall be prepared including details on responsibilities, structure, duties, qualifications, financing, and financial impact.

BID FOR 2024 CONVENTION BY WASHINGTON LODGE

President Kathy Dollymore invited Dave Brown, the President of Washington Lodge, to the microphone. He announced that Washington Lodge would be very proud to present a bid for

hosting the next convention. He stated that the location would be central for District 3, there is plenty of tourist attractions, and it is easy to get there by all forms of transportation.

Dave reported that he has been in discussion with the Hyatt Regency in Herndon, VA. It is about 3 miles from Dulles Airport. The Metro Silver Line going to Dulles will be completed by 2024 and will offer a connection to Reagan National Airport, too. Also nearby is the new Air & Space Museum near Dulles (called the Udvar-Hazy Center) and the Sully Plantation.

The convention would be on June 7-10, 2024. The Committee has negotiated a room rate of \$129/night for Jr. Suites and this rate would apply for 3 days before and 3 days after the convention. There is free parking. Dave showed a video of the hotel and its rooms.

The proposed Delegate Package price would be \$319. There is a lovely outdoor patio which could be used. Suggested activities would be a Viking Auction on Sunday afternoon, lunch, dinners, and a bus tour of the DC monuments at night. He closed by saying that his Washington Lodge membership is excited to host.

VOTE: President Kathy Dollymore asked delegates if they would like to approve having the Washington Lodge host the 2024 3D Convention.

APPROVED through a show of hands and by acclamation.

President Dollymore suggested talking up the next convention to our lodge members, even if they only want to be non-delegates. Diana Syvertsen (paddle #75) asked if a non-delegate package price had been determined yet. Dave said "not yet".

LODGE OF THE YEAR AWARDS

President Dollymore said that these awards would be presented at the Grand Banquet this evening.

NEW BUSINESS AND FOR THE GOOD OF THE ORDER

- 1) International Secretary Marci Larson (paddle #14) thanked everyone for the wonderful experience she had serving on the International Board. She has met so many good people and lodges. She especially thanked the District Presidents, Gail Ekloff, Mary Andersen, and Kathy Dollymore, with whom she truly enjoyed working.

There was a plated dinner and dessert while delegates were entertained by a trio that included members of the Jacksonville Symphony. Awards and a live auction were also featured during the evening.

LIFETIME ACHIEVEMENT AWARD

President Kathy Dollymore called Zone 3 Director Audun Gythfeldt forward to read the two profiles that he wrote when nominating the two winners.

JØRGEN FIDJE

(The Award was given posthumously. Ingrid Hammen and Oddbjorg Olsen, friends of Jørgen and his wife Esther when they were at Gulfstream Lodge, received the award.)

As an immigrant from Mandal, Norway, Jørgen joined Sons of Norway in 1956 and quickly proved his value as a dedicated, strong an efficient leader who became a trusted front-runner at the lodge as well as the district and international levels of the organization.

Jørgen was Vice President, then President of Loyal Lodge. He then became Zone Chairman for what was then Zone 2, now Zone 1, and immediately after that became a member of the District Board as Zone Director. Jørgen was District Counselor for 4 years, District Vice President 2 years, and District President also for 2 years, which was the norm in those days. As District President he was strongly involved in organizing the celebration of the District's 75th anniversary in 1987, something that happened at the time when District membership was at an all-time high. During this time, he participated in and installed the officers of numerous lodges. I fondly remember Jørgen installing my lodge, having problems pronouncing my name. Following his 2 years as District President, he was elected International Director, and served on the International Board from 1988 to 1992.

Jørgen demonstrated dedication and leadership skills by serving in the positions listed above, but not only did he have leadership skills and organizational talent, he also had the foresight to realize the advantage of getting young people involved, and he was instrumental in forming

Loyal Junior Lodge where all his children served as President as well as other positions. And to top it off, he also served on the Loyal Lodge Corporation Committee.

Jørgen was chairman of the host committee for a very successful Third District Convention in Happauge in 1994, during which Loyal Lodge celebrated its 70th anniversary with a dinner cruise on Long Island Sound. He also served as co-chairperson for 4 other conventions, one of which was the stand-out International Convention in Washington D.C. in 2004.

Spearheaded by Bjarne Eikevik, former District and International President, Ski for Light was organized in this country, and Jørgen got into the act by participating in Ski for Light at Land of the Vikings. He was Sons of Norway through and through but was able and willing to also offer his support for other valuable purposes.

The picture of Jørgen would not be complete without including what he has meant for Land of the Vikings. From day one he was strongly involved in converting and improving LOV from what it was when the District took ownership in 1978 to what it has become today. There were continuous needs, and Jørgen was there, work weekend after work weekend. And then came

the expansion of the kitchen and the new meeting room upstairs, a job he had a major hand in. After that followed several years with more work weekends. But he wasn't done. Not long ago he and his son fixed the broken front steps. And he wasn't finished yet. When there was a need for a fund raiser for LOV, Jørgen made a gorgeous Viking ship that was filled with booze and raffled off at the 2018 Convention. And if that wasn't enough, he has made another one, and a beautiful stabbur, to be raffled off at the 2020 Convention in Jacksonville.

Jørgen Fidje, a man of many talents and dedication to the Third District and Sons of Norway is richly deserving of the Lifetime Achievement Award, and it is my great pleasure and honor to submit his name as a candidate.

BARBARA BERNTSEN

There are people who stand out as strong, efficient, and dedicated leaders. Barbara Berntsen is such a person.

Barbara became a member of Sons of Norway in 1972, and got involved in the activities of Garborg Lodge, and held various offices, including those of Secretary, and President, the latter from 1996 to 1999. Other notable lodge offices she held were Foundation Director and Cultural Director. As Cultural Director she has produced articles in the lodge newsletter covering the rich Norwegian cultural history, something she is still doing in her lodge newsletter as the assistant editor. It is worth mentioning also that Barbara was the chair of the Bazaar Committee for 10 years, proving her talents as an organizer, as well as her dedication to the lodge.

Barbara emerged at the District level when she served as the Secretary of the Convention Committee for the 1996 District Convention hosted by the District in the Catskills. Two years later she was elected District Secretary, a post she held for 6 years. Having been involved at this level in the District, we know that the Secretary's job is demanding and time consuming, but Barbara tackled the job confidently and efficiently, with an amazing ability to get things done in time. During the last two years of her time as District Secretary she also served as Secretary for the 2004 International Convention Committee for the convention hosted by the Third District in Washington D.C.

Barbara was also a Leadership Workshop facilitator for the District and has served on several convention committees during and after her time as District President. During her time as District President she served as Secretary on what is now referred to as the District Presidents Advisory Committee. At some point during her presidency, companies were getting into

extraction of shale gas in Pennsylvania, and leased excavation rights from property owners. Barbara became aware that this was happening in the LOV area and took action that eventually led to signing the deal that paid 3D Limited almost \$ 230,000. This alone should make her worthy of a prize.

Following her four years as District President, Barbara was elected International Director for the years 2008-2012. During the last two years of her term as International Director she was elected International Youth Director by the International Board. On the International Board she served on several committees. She chaired the Benefits Committee, and she was on the Lund Family Fund Committee, raising funds to establish the Lund Family Fund for the Sons of Norway Foundation. To crown her many efforts and achievements at the international Board level, Barbara was the secretary of the Charter, Constitutions and Procedures Committee, which made its recommendations to the International Lodge Meeting in 2012.

Land of the Vikings has been near and dear to Barbara's heart, and she and husband Roy has spent endless hours working at the facility. There are some of us remembering Barbara

crawling under the floor of the main building tracing electrical wires or clearing snow off the roof. And for the last several years she has served on the LOV Board as Secretary.

It will come as no surprise that Sons of Norway is not the only organization Barbara has been interested in and helped. She has been involved with the 17th of May Committee for the Greater New York, and for many years has been Secretary and Greater Chair of the organization. She has been working with the Norwegian Immigration Association, and was their Membership Secretary for many years, and she lent her organizational talent to the Nassau County, NY, District PTA, where she was Vice President from 1994 to 1998.

There is no doubt that Barbara Berntsen is deserving of the Lifetime Achievement Award, and I am proud and honored to submit her name as a candidate.
